- 1. I am an attorney with the law firm of Simon Monahan & Simon, L.L.C., attorneys for the Plaintiff, Lakulish Investment Group, LLC, in this action. I make this certification in support of Plaintiff's application for a Warrant for Arrest of Defnedant, Ojas Patel, for failure to comply with an Order of this Court entered September 18, 2017.
- 2. On February 13, 2017 Plaintiff obtained a judgment against the Defendant, Ojas Patel, in the amount of \$473,227.28. A copy of the Judgment is annexed hereto as "Exhibit A".
- 3. On March 1, 2017 Defendant, Ojas Patel, contacted me by telephone to advise that he was in the process of liquidating some investments and would be paying the judgment in full within a few weeks.

- 4. On March 15, 2017 I served an Information Subpoena upon Ojas Patel by First Class U.S. Mail and by Certified Mail, RRR...
- 5. On March 20, 2017 Ojas Patel and contacted me by telephone to advise that he was expecting to receive funds from an investment in Florida and expected to pay at least \$200,000.00 of the judgment within one week.
- 6. I notified Mr. Patel that he was nevertheless required to provide responses to the Information Subpoena.
- 7. Mr. Patel has never made any payment toward the judgment and did not timely respond to the Information Subpoena.
- 8. On April 3, 2017 I called the Defendant and left a message advising him of his failure to comply with the information subpoena and of my intention to file a motion to enforce litigant's rights. I did not receive a response to the Subpoena and the Court entered an Order to Enforce Litigant's Rights was entered on April 28, 2017.
- 9. Defendant subsequently sent an Information Subpoena indicating that he had no sources of income or assets other than a bank account at Wells Fargo.
- 10. A Writ of Execution issued thereafter to Wells Fargo Bank was returned with a statement that the account was closed.
- 11. The Defendant's statements that he was awaiting return of investment funds was directly inconsistent with his responses to the Information Subpoena that he had no assets other than the Wells Fargo account which he closed.
- 12. On June 26, 2017 a Subpoena was issued to Defendant directing him to appear for a deposition on July 11, 2017.

13. The defendant responded to the Subpoena by email on July 7, 2017 advising that he needed

to reschedule the deposition.

14. By Order dated September 18, 2017 the defendant was directed to attend a deposition on

October 20, 2017 at my office. A copy of the Order is annexed hereto as "Exhibit B". The

Order provided that if Defendant failed to comply a warrant for his arrest would be issued.

15. By email dated September 24, 2017 the Defendant acknowledged receipt of the Order and

confirmed that he would appear as scheduled. On October 19, 2017, however, Defendant

stated that the deposition needed to be rescheduled as he did not have all documents

requested. Defendant was reminded that the deposition was Court Ordered and directed

to appear with whatever documents he had. The Defendant did not appear despite the

Court Order. By email dated November 2, 2017 Defendant stated that he would come to

my office the following week to bring documents and a payment toward the judgment. A

copy of the series of emails is annexed hereto as Exhibit "C" and incorporated herein.

15. The Defendant never produced any of the requested documents, never appeared for the

Court Ordered deposition and has not made any payment as promised.

16. The Defendant has failed and refused to comply with the Order of the Court and it is

respectfully requested that the Court issue a warrant for Defendant's arrest to compel his

appearance.
